# FIRST AMENDMENT TO CONTRACT BY AND BETWEEN THE CITY OF DENTON, TEXAS AND RELIEF SERVICES FOR VETERINARY PRACTITIONERS RFP NO. 5626

"Total Contract Amount for services shall not exceed \$900,000 per term. Pricing shall be per Exhibit C attached."

All other provisions of the contract 5626, as heretofore amended, remain in full force and effect.

#### **Electronic Record and Signature Disclosure**

#### ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, City of Denton (we, us or Company) may be required by law to provide to you certain written notices or disclosures.
